

DELSEY FLY ME TO THE FRENCH RIVIERA PROMOTION

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

- 1. PROMOTION PERIOD:** The DELSEY Fly Me to the French Riviera Promotion (“Promotion”) begins on November 1, 2016 at 10:00 a.m. Eastern Time (“ET”) and ends on December 31, 2016 at 11:59:59 p.m. ET (“Promotion Period”).
- 2. ELIGIBILITY:** The Promotion is open only to legal residents of the 50 United States and the District of Columbia who are at least 18 years of age at the time of entry. Employees of DELSEY (“Sponsor”), any agencies involved in the Promotion, and each of their respective parent and affiliate companies, as well as the immediate family (spouse, parents, siblings and children, including “in-laws”) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.
- 3. HOW TO ENTER:** During the Promotion Period, you can enter the Promotion at <http://www.DELSEYFlyMeToFrance.com> (the “Website”). Visit the website and follow the instructions to register by submitting your complete and accurate information, including first and last name, full mailing address, email address, and phone number, and answering several short questions, to receive one (1) entry into the Promotion. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Promotion. **Limit one entry per person/email address.**

Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant’s entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

- 4. PRIZE DRAWING:** Sponsor will randomly select the potential Promotion winners from all eligible entries received during the Promotion Period, on or around January 10, 2017. The potential winners will be notified by email, mail or phone. Winning a prize is contingent upon fulfilling all requirements set forth herein.

(ii) five (5) days, four (4) nights hotel accommodations (one (1) double occupancy room, room rate and tax only) (accommodations determined by Sponsor in its sole discretion);

(iii) ground transfers between Airport and Hotel in Nice;

(iv) a French Riviera activities pass for each guest;

(v) \$1,000 spending money, awarded as a check;

(vi) three (3) pieces of DELSEY Bastille Lite Luggage, - (one (1) carry on, one (1) medium upright, and one (1) large upright)

ARV of the Grand Prize: \$7,102

Total Approximate Retail Value of all prizes: \$10,282

Actual value of the Grand Prize may vary based on airfare fluctuations and point of departure. If total airfare exceeds \$2,500.00, winner and guest will be responsible for the difference. Grand Prize Winner will not receive the difference between actual value and ARV. Trip must be booked at least forty five (45) days prior to departure. Trip subject to availability and blackout dates. Travel must be round-trip. Travel and accommodations are subject to availability. Travel is subject to the terms and conditions set forth in this Promotion, and those set forth by the Sponsor’s airline carrier, as detailed in the passenger ticket contracts. All expenses and incidental travel costs not expressly stated in the package description above, including but not limited to, ground transportation, meals, incidentals, passenger tariffs or duties, surcharges, airport fees, service charges or facility charges, personal charges at lodging, security fees, taxes or other expenses are the responsibility solely of the Grand Prize Winner. Prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Winners are responsible for all taxes and fees associated with prize receipt and/or use.

All applicable taxes including federal, state, and local income taxes, if any, are the sole responsibility of the Winners. No cash substitution, assignment, redemption for cash, or transfer of prize by winner is permitted. However, Sponsor reserves the right, in its sole and absolute discretion, to substitute any prize described herein, or any portion thereof, with an alternate prize of equal or greater value. Odds of winning depend on the number of eligible entries received during the entire Promotion Period.

6. **WINNER VERIFICATION AND CLAIMING A PRIZE:** Potential winners are subject to verification of eligibility and compliance with these Official Rules. All potential winners are subject to review for eligibility by Sponsor, whose decision is final and binding in all matters related to the Promotion. Potential winners that do not meet the requirements set forth in these Official Rules, as determined in the sole discretion of the Sponsor, will be disqualified. Potential Winners will be notified via email and will be required to sign and return a Declaration of Eligibility, Liability/Publicity Release and Form W9 ("Prize Documents") within five days of the date such email is sent. If a Potential Winner is found to be ineligible or not in compliance with these Official Rules, fails to return the Prize Documents within the specified time, declines to accept a prize, or Sponsor is unable to contact a Potential Winner for any reason, or in the event that a prize notification is returned undeliverable, the prize may be forfeited and, at the Sponsor's sole discretion, prize may be awarded to an alternate Potential Winner. Potential Winners may be required to furnish proof of being authorized account holder of the Email address used to enter.

By accepting a prize, each Winner consents to the use of his/her name, address (city and state of residence), voice, and statements relating to the Promotion or Sponsor, and photographs or other likenesses, without further compensation, notification or permission in any publicity or advertising carried out by Sponsor or any related entities in any and all media now known or hereinafter developed without territorial or time limitation, except where prohibited by law.

7. **PROMOTION OPERATION:** Sponsor reserves the right in its sole discretion to cancel, modify or suspend this Promotion at any time, if fraud, technical failures, including any network server or hardware failure, viruses, bugs, errors in programming, or any other errors or other causes corrupt the administration, security, integrity or proper play of the Promotion. In the event of cancellation, prizes will be awarded in a random manner to be determined by Sponsor.

8. **RELEASE & LIMITATION OF LIABILITY:** As a condition of entering the Promotion, each entrant agrees, and as a condition of being awarded a prize, each winner agrees, to release, indemnify and hold harmless Sponsor, and its officers, directors, shareholders, members, employees, agents and assigns and all others associated with the development and execution of this Promotion (the "Released Parties") from and against any and all liabilities, claims, actions, lawsuits, judgments, costs and expenses, damages of any kind whatsoever, injuries, or losses to persons or property arising from, resulting from or in connection with the Promotion, submitting an entry or otherwise participating in any aspect of the Promotion, the receipt, ownership, possession, use or misuse of any prize awarded or any typographical or other error in these Official Rules or the announcement of offering of the prize. Released Parties are not responsible for (a) lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet Service Providers, web sites, or other connection, availability or accessibility problems arising in connection with or over the course of the Promotion; or (b) failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions or hardware or software malfunctions, failures or difficulties; or (c) failure of personal computers and/or software and hardware configurations, any technical malfunctions, failures, or difficulties, printing errors, clerical, typographical or other error in the offering or announcement of any prize or in any prize notification documents or any other Promotion-related materials; or (d) for any other errors of any kind relating to or in connection with the Promotion, whether human, mechanical, clerical, electronic, or technical in nature, including, but not limited to, errors which may occur in connection with the administration of the Promotion or the processing of entries or the cancellation of the Promotion; or (e) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the Promotion; or (f) damage to a user's system occasioned by participation in this Promotion or downloading any information necessary to participate in this Promotion; incomplete, illegible, misdirected, damaged, or lost entries; or any technical, hardware or software malfunctions, telephone failures of any kind, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, garbled or delayed electronic communications, whether caused by the sender, by any of the equipment or programming associated with or utilized in this Promotion which may limit the ability to participate, or by any human error which may occur in the processing of the entries or otherwise in administering this Promotion.

9. **ADDITIONAL TERMS:** In the event of any conflict with any Promotion details contained in these Official Rules and Promotion details contained in any Promotion materials, the details of the Promotion as set forth in these Official Rules shall prevail.

The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or

illegal provision were not contained herein. In particular, Sponsors' employees are not authorized to waive, modify or amend any provision or provisions of these Official Rules in any manner whatsoever.

10. **JURISDICTION/CHOICE OF LAW:** All participants consent to the jurisdiction and venue of the federal and state courts located in the State of Maryland for the resolution of any and all disputes or claims, and agree that all such claims shall be brought exclusively in one of those courts. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participants and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of Maryland without regard to the conflicts of law principles thereof.
